DIRECTIONS FOR USE

FERTIGATION (Including Drip Irrigation): Apply ½-20 gallons per acre. Drip lines and emitters may need to be opened and flushed to remove insoluble particulate matter dislodged by the treatment with this product.

BANDED APPLICATIONS: Apply ½-20 gallons per acre.

EQUIPMENT: Use of aluminum, brass, copper, nylon and mild steel components for transfer and storage are discouraged. Corrosion or mild etching of aluminum, brass, copper, or nylon irrigation system components may occur depending on injection rate and concentration.
