Intracapt-O is a complexed micronutrient designed as a foliar or soil applied nutrient. This product has been developed to promote nutrient penetration, uptake and utilization.

Intracapt-O should be applied at planting or at the beginning of stressful growth stages such as first true leaf, flowering and fruit set. It is water soluble and non-toxic to plants when applied as directed.

Intracapt-O may be used on a variety of crops such as legumes, small grains, root crops, vegetable

DIRECTIONS FOR USE

Observe all precautions and limitations on this label and labels of products used with Intracapt-O.

APPLICATION INSTRUCTIONS

Foliar: Apply in an adequate amount of water that will provide complete coverage of the plants. Use of a non-ionic wetting agent may improve spray coverage of certain hard to wet plants. Intracapt-O can be included in a regular spray program on crops.

Soil: In a planter band application a soil barrier between the seed and Intracapt-O is preferred. Consult with your Certified Crop Advisor regarding compatibility with other materials and for proper rate and timing of applications. The rate and timing of application will depend on the crop and stage of growth.

RECOMMENDATIONS

Potatoes: Apply 16 to 32 fl. oz. per acre. Intracapt-O can be applied in a planter band followed by a foliar application at the appropriate time. Applications may be repeated two or more times throughout the growing season. Consult with your Certified Crop Advisor for varietal restrictions.

Fruit Trees: Apply 16 to 32 fl. oz. per acre before blossoming and shortly after petal fall.

Melons and Vine Crops: Apply 16 to 32 fl. oz. per acre at first female flower and again at softball-sized fruit.

Onions: Apply 16 to 32 fl. oz. per acre at bulb initiation (1/2" to 3/4" diameter). Applications may be repeated two or more times throughout the growing season. A second application (1.5" to 2" bulb diameter) is recommended.
