Soil: In a planter band application a soil barrier between the seed and Intracept-O is preferred. The rate and timing of application will depend on the crop and stage of arowth.

RECOMMENDATIONS

Potatoes: Apply 16 to 32 fl. oz. per acre. Intracept-0 can be applied in a planter band followed by a foliar application at the appropriate time. Applications may be repeated two or more times throughout the growing season. Consult with your Certified Crop Advisor for varietal restrictions.

Fruit Trees: Apply 16 to 32 fl. oz. per acre before blossoming and shortly after petal fall.

Melons and Vine Crops: Apply 16 to 32 fl. oz. per acre at first female flower and again at softball-sized

Onions: Apply 16 to 32 fl. oz. per acre at bulb initiation (1/2" to 3/4" diameter). Applications may be repeated two or more times throughout the growing season. A second application (1.5" to 2" bulb diameter) is recommended.
