## DIRECTIONS FOR USE

**MIXING:** Fill spray tank 1/2 full, add the desired amount of herbicides and continue filling. Add the **KAMMO™ PLUS** last. After filling, continue agitation.

**RIGHTS-OF-WAY, FORESTRY, INDUSTRIAL AND RAILROADS:**

Foliar – 1 pt. to 2 quarts per acre.  
Dormant – 1 to 2 gallons per acre.

**AQUATICS:**

Surface – 1 pint to 2 quarts per acre.  
Submerged – 1 or 2 gallons per acre.
