**KickStand® DG+Fe** can be applied to trees, vines, ornamentals, lawns, and garden landscaping.

**TURF & ORNAMENTAL USE:** Turf: Apply 1-2 lbs. per 1,000 square feet. Apply 200 lbs. of KickStand® DG+Fe per 1,800 lbs. of divot sand or 200 lbs. of KickStand® DG+Fe per cubic yard of divot sand. **Ornamentals:** Mix 5 lbs. per cubic yard of potting soil. Water in thoroughly. **Trees and Vine Use:** Apply 2 lbs. per 1,000 square feet of soil surface, or 1/4 lb. per inch trunk diameter on larger trees/shrubs/vines and thoroughly water in.
