### GENERAL INFORMATION

Kovar Fortitude SR is a proprietary modified seed oil product designed to retain the active ingredients of both pesticides and fertility products when applied to the soil for increased product efficiencies. Kovar Fortitude SR binds the actives to the soil colloids thereby reduces potential to leaching of the products out of the top soil surface and maintains availability of the product for greater uptake by the plant over an extended time. This generally results in improved pesticide control or prolonged nutrient uptake.

Kovar Fortitude SR also enhances uniform droplet size which aids in better deposition on the target surface as well as mitigating off target drift.

Kovar Fortitude SR is approved for use with many traired herbicide technologies. Always check with the herbicide manufacturers website for the most current approvals.

This product is not recommended for aquatic use.

### DIRECTIONS FOR USE

Kovar Fortitude SR is registered to be used at a rate of 8 -16 oz. per acre. Using the higher rates may negate the need for additional adjuvants. When used with a post emergent residual herbicide do not exceed 8 oz. per acre. **Do not use this product at rates in excess of 5% of the finished spray volume.**

The addition of Kovar Fortitude SR should only be done once all other spray mixture products have been well agitated in the tank. Always add Kovar Fortitude SR last to the tank.

Review both the adjuvant and herbicide label before use. Recommendations and restrictions on the pesticide label take precedence over any recommendations presented on this label. Kovar Fortitude SR may be applied by ground, air or other spray equipment that is listed on the herbicide label.
