### GENERAL INFORMATION:

LEAF LIFE SLINGSHOT™ is a buffering agent specially designed for lowering the pH of irrigation water. LEAF LIFE SLINGSHOT contains high concentrations of citric acid. The application of LEAF LIFE SLINGSHOT to irrigation water complexes minerals in both the water and the soil. The optimum pH in irrigation water is between 5.3 to 6.0, and citric acid is ideal as an acidifier for reducing the pH. LEAF LIFE SLINGSHOT can be applied to all crops including fruit trees, vines, tree nuts, fruits and vegetables, field and row crops, ornamental trees, shrubs and flowers, containerized plants, and turf. LEAF LIFE SLINGSHOT is not for aquatic use.

### DIRECTIONS FOR USE:

**For use in Agriculture, Nurseries and Greenhouses:** Use this product to buffer spray mix pH level. Application rates depend on water pH and buffering capacity; therefore, use a pH meter to determine proper level of this product in the tank mix. Typical use rates are between 1.0 to 2.0 ounces per 100 gallons of water. This product can be used with all conventional application equipment, including air blast.

**For Irrigation Water:** Use LEAF LIFE SLINGSHOT to lower the pH of irrigation water, when the pH of the water is above the acceptable pH range 5.2 to 6.8. The suggested use rate is 4.0 to 15.0 fluid ounces per 1000 gallons of water. Use rates may vary depending on the test results of the irrigation water.

### STORAGE AND DISPOSAL

**STORAGE:** Store in cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container. Avoid storage below 32° F. If product freezes, warm and agitate (recirculate) prior to using.

**DISPOSAL:** Do not contaminate water, food, or feed by storage or disposal. Dispose of contents/containers on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
