DIRECTIONS FOR USE

When applying **LINK CENTERPIECE**, maintain agitation to provide uniform distribution within spray tank. If a spreader is desired or recommended in the mix, use a high quality CPDA-approved spreader, such as RAINIER-EA® or DENALI-EA™, at recommended rates to improve spray coverage. Do not apply when plants are under excessive heat or moisture stress.

TURFGRASS

Greens and Tees: Apply 6.4-38 ounces per 1,000 sq. ft. with sufficient water to prevent tip burn (1-2 gallons). Repeat as needed. Corresponding rates per acre are 2-11 gallons per acre in 40-80 gallons of water.

Fairways and Lawns: Apply 12.8-40 ounces per 1,000 sq. ft. with sufficient water to prevent tip burn (1-4 gallons). Repeat as needed. Corresponding rates per acre are 4.5-13.5 gallons per acre in 40-160 gallons of water.
