DIRECTIONS FOR USE

SHAKE WELL BEFORE USE. KEEP FROM FREEZING

Dilute one part LPI 23 with 20 or more parts water. Apply by a spray method and adequate amount of water that will provide complete coverage of plants. Listed rates are based on application to mature, full-sized crops. Reduce rates proportionately when spraying smaller, younger plants.

FIELD AND VEGETABLE CROPS

Apply 1.0 to 4.0 quarts per acre during periods of rapid growth or nutritional stress. Repeat 2 or more times through the growing season or as needed.

TREE CROPS

Apply 1.0 to 4.0 quarts per acre after the beginning of active growth. Further applications may be made at 2- to 4-week intervals throughout the growing season.

GRAPES AND BERRIES

Apply 1.0 to 4.0 quarts per acre after active growth begins. Repeat at 1-week intervals through active growth periods.

FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.
