GENERAL: When applied as directed, **LT 120** will help manage water repellency conditions for 120 days in the soil profile. **LT 120** will help prevent localized dry spot conditions from forming if used early in the season or before water repellency conditions appear. **LT 120**, when used according to label rates, is safe to turf. **LT 120** has not burned turf when applied according to label directions.

DIRECTIONS FOR USE: Greens, Tees, Fairways, Lawns, Parks and Sports Turf
Localized Dry Spot and Water Repellency Conditions: Apply **LT 120** as a preventive program. **LT 120** should be applied in 2 applications. Apply at 8 ounces per 1,000 sq. ft. Wait 60 days to reapply second application. Under the 2 split applications, **LT 120** should be sprayed at 8 ounces per 1,000 sq. ft. and should be applied in 2 gallons of water per 1,000 sq. ft. spray solution.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents/container on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities.
