**RECOMMENDED RATES**

**Row or Band:** 1 to 2 quarts per acre before or at planting

**Broadcast:** 2 to 2.5 quarts per acre mixed into the top 3 to 5 inches of soil

**Foliar:** 1 to 2 pints per acre \*\*

\* COMPATIBILITY - Check compatibility before mixing with orthophosphates and other chemicals. MANGANESE 6% is compatible with most fertilizers including suspensions, polyphosphates and nitrogen solutions.

\*\*A water conditioner (ammonium sulfate) is recommended when mixing with glyphosate herbicide.
