GENERAL INFORMATION

MAX SET® MZ 38 is designed to prevent or correct manganese and zinc deficiencies in a wide range of agronomic and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality. Application of MAX SET MZ 38 is a means of obtaining a quick response to needed elements. Foliar applications of MAX SET MZ 38 may be particularly beneficial during periods of peak nutrient demand, for crops grown on soils having poor nutrient availability or to crops suffering from a weakened root system.

*Phosphorous acid products are intended to be used as a supplemental fertilizer treatment. Upon foliar application, the phosphite ions are taken up directly by the plant foliage and may undergo a degree of conversion to phosphate ions or are utilized directly by plants as phosphite ions. As a soil application to annual crops, a lesser response from the initial crop with corresponding superior response from succeeding crops may be observed. In addition, placement close to seeds or root zones may be injurious to crops. The effect may be aggravated by a soil pH below 6.5.

MAX SET MZ 38 should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield and quality.

DIRECTIONS FOR USE

MAX SET MZ 38 may be applied as a foliar spray by air, ground concentrate or dilute. Maintain agitation to provide uniform distribution within spray tank. Use of a high quality CPDA approved spreader, such as R-11®, at recommended rates to improve spray cover is usually advised. Do not apply when plants are under excessive heat or moisture stress. Applications of foliar nutrients to leafy vegetables or soft-skinned fruit during periods of excessive temperatures may cause cosmetic injury. Applications of certain micronutrients to fleshy fruit within 30 days of harvest may result in staining of rind or skin.

FIELD AND ROW CROPS: Apply 1-3 pints per acre with sufficient water for thorough coverage. Make application prior to bloom on a crop such as cotton or within 40 days of a plant's grain development on a crop such as corn.

OTHER CROPS: Apply 1-3 pints per acre with sufficient water for thorough coverage.

MAX SET MZ 38 contains free phosphorous acid. Care should be taken on sensitive crops that are prone to phytotoxicity.

COMPATIBILITY

MAX SET MZ 38 is formulated to achieve an acidic spray solution. Final spray solution pH will vary depending on rate, water volume and quality. Do not combine with copper plant protection products if spray solution has a pH of 6.5 or less. Always jar test new combinations for compatibility prior to field mixing.

Excessive acidification may solubilize metals and cause phytotoxicity. Always test spray tank pH prior to application. Do not combine with copper crop protection chemicals or apply to crops within 30 days of having been treated with copper crop protection chemicals. Do not apply with silicone-based adjuvants at rates exceeding 4 ounces of organosilicone per 100 gallons of water. Do not apply in combination with 2 or more emulsifiable concentrate- or oil-based pesticide formulations.
