FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

GENERAL INFORMATION

MICROMINOR™ can be used in combination with water soluble plant nutritional products which are formulated for foliar, sidedress or drip irrigation application. May be applied alone or in tank mixes containing fertilizers, fungicides and/or pesticides. MICROMINOR is believed to be compatible with most agricultural water-soluble plant nutritional products. If physical compatibility with another fertilizer product is unknown, use a jar compatibility test. The addition of calcium to the MICROMINOR blend is recommended. When applying MICROMINOR blend as a foliar spray, always use a spreader penetrant such as WIDESPREAD® MAX.

ONCE PRODUCT IS DILUTED, USE WITHIN 24 HOURS

DIRECTIONS FOR USE

Citrus & Avocados: 1.0 to 4.0 quarts per acre. Apply after first flush in spring. Repeat applications every 2 to 4 weeks as necessary.

Deciduous Fruit & Nut Crops: 1.0 to 4.0 quarts per acre. Apply as needed throughout the growth season.

Field & Vegetable Crops: 1.0 to 4.0 quarts per acre. Begin applications when plants are 6 to 8 inches in size.

Grapes & Berries: 1.0 to 4.0 quarts per acre. Apply as needed during periods of active growth.

Hops: 1.0 to 3.0 quarts per acre as needed.

Ornamental Tree, shrubs and flowering plants: Apply at dilution rate of 3.0 ounces in 1.0 gallon of water. Spray to run off. Apply as needed at spray intervals of 14 days or more.

Turf: 0.5 to 1.0 fluid ounces per 1,000 square feet. Weekly applications as needed.

STORAGE AND DISPOSAL

STORAGE: Store in original containers only. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Store at ambient temperatures. Do not contaminate water, food, or feed by storage or disposal.

DISPOSAL: Do not reuse container. Plastic: Triple rinse (or equivalent), adding rinse water to spray tank, then offer for recycling at an ACRS site (go to <http://www.acreecycle.org/> for locations) or by reconditioning, or puncture and dispose of in a sanitary landfill or
