FIRST AID

GENERAL INFORMATION

Mystic Hue is a green colored turf colorant which will improve visual color of dormant and non-dormant turfgrass. The unique color combination in Mystic Hue is designed to mimic actively growing grass.

When mixing Mystic Hue[®] with another product If the applicator does not have experience using this product, a phytotoxicity and jar test should be performed to confirm plant safety and tank mix compatibility with a specific spray mix. When mixing Mystic[®] Hue, fill the spray tank with water and start agitation, add product then fill remainder of the tank with desired solutions. Do not apply to food or feed crops or grain after harvest. This product is not intended for use on edible food crops.

Turf (Including but not limited to golf courses, commercial, residential, sports turf, sod farms, parks): Apply at a rate of 6% v/v or 1 - 4 gallons per acre. Ideal application is 40-50 gal of mixed product per acre. Higher heights of cut may require higher rates and possibly application in two directions to achieve uniform or desired coloration. Additionally, semi-dormant and dormant turf require higher rates and possibly application in two directions to achieve desired coloration. Make subsequent applications as needed to achieve desired color.

Thoroughly clean sprayer, tank and hoses after each use.
