#### **APPLICATION RATES**

FOLIAR: Apply 1-2 qt per acre (32-64 fl oz)
IN-FURROW OR 2x2: Apply 1-4 qt per acre (32-128 fl oz) with liquid UAN.
CROP RESIDUE: Apply 1-4 qt per acre (32-128 fl oz) alone or in
combination with in-furrow products or liquid starter fertilizers.

Store in a cool, dry place in original container. Avoid freezing. Keep container tightly closed. Do not reuse empty container.
