#### **GENERAL INFORMATION**

N-TER 10<sup>®</sup> is a blend of a high quality nonionic surfactant and liquid 28% nitrogen. N-TER 10 can enhance the efficacy of those herbicides which recommend the use of 28% nitrogen. N-TER 10 brings together the benefits of nonionic surfactant activity and increased uptake from nitrogen into a convenient premix.

#### **DIRECTIONS FOR USE**

Add N-TER 10 to the spray tank mix at the rate specified by the herbicide label. See chart for information on rates. Before mixing spray solution, it is recommended that a compatibility test be performed in a small container. If all components of the spray mix are compatible, add the contents of the smaller container to the spray tank and begin mixing operation.
