NIRVANA is a new, patented catalyst designed to improve EC pesticide compatibility with fertilizers. This one of a kind, proprietary blend forms a bridge between the pesticide and the fertilizer. **NIRVANA** does not lower the Ph of the application tank. **Nirvana** helps make the pesticide disperse readily for even distribution of the pesticide and fertilizer at time of application. **Nirvana** can be used with 10-34-0 and other starter fertilizers. Although **NIRVANA** is one of the most powerful catalysts on the market, a jar test is recommended prior to mixing in the tank. **NIRVANA** can be added directly to the fertilizer or micro-nutrient solution.

Directions For Use

NIRVANA is intended for the use with a wide variety of pesticide EC's for agricultural crops. **NIRVANA** is not a pesticide and should always be used with an EC insecticide for proper insect control. **NIRVANA** may be used in conventional spray equipment and fertilizer direct injecting equipment. Always follow the listed rates of the pesticide.

Application or Use Rates

Determine proper rate of product based on type of application and type of pesticide formulation being used. Product should be added to the fertilizer or micro-nutrient first, followed by the EC. Not recommended for the use with suspension concentrates.

Suggested use rates: 6.4-12.8 oz /Acre

MIXING

NIRVANA may be mixed with pesticide EC's in injecting equipment or conventional spray equipment. Fill the tank half full of liquid fertilizer and begin spray tank agitation. Add **NIRVANA** first and then add the rest of the liquid fertilizer. Add pesticide according to the pesticide label under agitation. **NIRVANA** may be premixed with aqueous based fertilizers such as 10-34-0 or other pop-up fertilizers, a compatibility jar test should be conducted with the formulation being used. **NIRVANA** will aid in evenly distributing the pesticide in the fertilizer, it is recommend to continue the agitation of the spray tank. If the fertilizer and pesticide sit for a period of time and separation starts to occur, **NIRVANA** is designed to enable the mixture to be re-suspended with agitation to again evenly distribute the mixture. The higher rate of **NIRVANA** may be needed for some starter fertilizer. A higher rate will improve compatibility with the starter fertilizer.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product.

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
