NUCLEUS® HYPERLINK HP 8-24-4 is intended as a supplement to a regular fertilization program and will not, by itself, provide all the nutrients normally required by agricultural crops. The following is a guide for the use of NUCLEUS® HYPERLINK HP 8-24-4 50/50 as a plant nutrient.
