GENERAL INFORMATION

This fertilizer contains phosphorous and may not be used on turf in the state of Maryland.

NUCLEUS® ORTHO-PHOS is a stabilized solution containing a high concentration of 100% water soluble orthophosphate in combination with nitrogen and EDTA chelated iron.

NUCLEUS® ORTHO-PHOS is compatible with many liquid fertilizers and pesticides, provided that the following guidelines are followed:

1. Do not mix NUCLEUS® ORTHO-PHOS with undiluted pesticides.
2. Mixtures of NUCLEUS® ORTHO-PHOS with fertilizers based on potassium thiosulfate and/or ammonium thiosulfate should be applied directly after mixing.
3. Do not mix or apply with products containing calcium, magnesium, copper, manganese, zinc or iron unless they are **fully** chelated.
4. Do not combine with antibiotics or spray oils.
5. Always "Jar Test" all tank mixes for compatibility before mixing for field applications.

GENERAL RECOMMENDATIONS

NUCLEUS® ORTHO-PHOS may be applied to agricultural plants and/or turf where applications of nitrogen and/or phosphorous are recommended. NUCLEUS® ORTHO-PHOS should be used at the rate of 2-10 Gallons per Acre – depending on plant needs. NUCLEUS® ORTHO-PHOS when used as directed, this product does not supply all nutrients required by plants and is to supplement a soil fertility program based on soil tests. NUCLEUS® ORTHO-PHOS may be applied through ground application or irrigation equipment. For ground applications equipment, NUCLEUS® ORTHO-PHOS may be applied alone or in combination with water and/or liquid fertilizer.

In Virginia, this lawn/turf fertilizer contains phosphorous and is only for nonagricultural use on (i) turf during its first growing season, (ii) on turf areas being repaired or renovated, and (iii) on turf where a soil test performed within the last 3 years indicates a phosphorous deficiency. This fertilizer is not for the routine maintenance of turf.

APPLICATION AND MIXING GUIDE

APPLICATION RATES: 2 to 10 gallons per acre according to soil fertility/crop needs.

Product should not be used if plant is under stress from pests, heat or inadequate soil moisture.

USE GUIDELINES:

In-Furrow:

- Corn: Apply 3 to 5 gallons per acre
- Potatoes: Apply 3 to 5 gallons per acre
- Wheat: Apply 2 to 5 gallons per acre
- Beans (soya, edible, dry): Apply 2 to 3 gallons per acre. Use lower use rate on lighter soils.

Sunflowers: Apply 3 to 5 gallons per acre

Sugarbeets: Apply 3 to 4 gallons per acre

2x2/Side Dress: 2 to 10 gallons per acre

PLANTS:

Citrus: (Established) Apply 2-4 gallons per acre per application in 2 or more applications per season via fertigation.

Drench Application: (Established/transplanted/young trees) Mix 10 gallons of NUCLEUS® ORTHO-PHOS with 35 gallons of water. Apply 1.0 to 2.5 ounces per tree every 6-12 weeks.

Cotton: Apply 1 to 3 gallons per acre as a 2x2 placement in the soil. Not recommended for use in-furrow.

Chemigation/Water Run: 2 to 10 gallons per acre

Turf: Apply 6 to 12 fl. ounces per 1,000 sq. ft. using 2 to 5 gallons of water per 1,000 sq ft. Apply as needed.

DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN.

MIXING: In any mixing operation introduce NUCLEUS® ORTHO-PHOS in the following sequence:

1. Water
2. NUCLEUS® ORTHO-PHOS
3. Other Fertilizers
4. Pesticides or Soil conditioners

NOTE: NUCLEUS® ORTHO-PHOS may crystallize in freezing temperatures but will reconstitute in warmer temperatures.
