GENERAL INFORMATION

Special K 0-0-24 is a concentrated mixture of potassium fertilizer at a neutral pH.

DIRECTIONS FOR USE

Mixing Directions - Be sure spray tank is thoroughly cleaned, fill 1/2 full with clean water, add product and continue filling with agitation. Always add this product to tank before adding pesticides.

Compatibility - Special K 0-0-24 is recommended to be applied with nitrogen solutions and can be applied with other minerals and foliar fertilizers. When tank mixing with trace minerals, be sure minerals are properly chelated.

Applications - Special K 0-0-24 can be applied by ground equipment, drip or overhead irrigation systems.

Dilution and Spray Volumes - Always use enough water for uniform application and to prevent possible plant tissue damage to the intended crop from concentrated droplets.

Containers - Triple Rinse. Dispose of containers only in a manner approved by local and state authorities.

SUGGESTED APPLICATIONS

NOTE: Special K 0-0-24 is recommended for application on all crops. However, we strongly recommend that this product is used with the advice of a qualified crop nutrient consultant.

Direct row placement and foliar applications can result in plant damage.

ALL CROPS - SOIL APPLICATIONS

Side dress & Water run - 1 to 5 gals./acre.
In Row Applications - 1 to 5 gals./acre

ALL CROPS - FOLIAR APPLICATIONS

Foliar Applications - 1/2 to 3 gals./acre
