NUTRIO™ BREAKDOWN is specifically formulated to speed up the rate of crop residue decomposition. **NUTRIO BREAKDOWN** is compatible with soil conditioners and surfactants. If exogenous bacteria are to be added, they should be added at the same time.

DIRECTIONS FOR USE

NUTRIO BREAKDOWN can be used on all crop residues and in all cropping systems and should be applied at a rate of 16 fluid ounces per acre. This product can be applied by ground rig, backpack sprayer, aerial application, or through irrigation water. This product can be used in both tilled and non-tilled cropping systems. When used on tilled fields, it is recommended that the product be applied to the residue prior to tillage for best results.

NUTRIO BREAKDOWN can be mixed with glyphosate or any other herbicides and applied in both preplant or preemergence situations. It is recommended that this product be applied in a total spray volume of 10 gallons per acre to allow for thorough coverage of the residue. For aerial applications, it is recommended to use a total spray volume of at least 5 gallons per acre.
