## FIRST AID

Crop	Application Rate / fl. oz. product per acre	Application method / Timing	Remarks
Cereal grains, such as barley, wheat, rice, oats, rye, corn, millet and others	5-10 fl. oz. product	1st application during early vegetative stage. May repeat applications at 7-10 day intervals as required.	3-10 gals spray volume per acre
Pome/stone fruits, such as apple, apricot, cherry, plum, plumcot, and peach	64 fl. oz. product	1st application at 5-10% bloom. Repeat applications at 7-10 day interval as required.	100-200 gals spray volume per acre
Fruiting vegetables, such as tomato, pepper and eggplant	15 fl. oz. product by ground 2-5 fl. oz. product	1st application at early flowering stage and repeat every 10 days if required.	15-30 gals spray volume per acre by ground 3-8 gals spray volume per acre by air
Other crops	1:200 dilution rate	1st application at 5-10% bloom. Repeat applications at 7-10 day intervals.
