GENERAL INFORMATION

OPTIFY™ XX is a convenient adjuvant blend that contains a non-AMS water conditioner, surfactant, and drift reduction agent (DRA). This combination of ingredients provides durable drift control to reduce off-target movement, improves droplet spreading on the leaf, and reduces hard water antagonism of pesticides. OPTIFY™ XX is designed for use on dicamba-tolerant crops – always refer to the manufacturer website for the current tank mix approvals.

ENVIRONMENTAL HAZARDS

Not for aquatic use. Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high-water mark.

DIRECTIONS FOR USE SHAKE WELL BEFORE USING

Mix 2-3 quarts (0.5%-0.75% v/v) of OPTIFY™ XX per 100 gallons of spray solution.
