DIRECTIONS FOR USE

ORGANIC AMMONIUM NITRATE 10-0-0 contains ammoniacal nitrogen distilled from livestock manure. A portion of this ammoniacal nitrogen is converted to nitrate utilizing naturally occurring bacteria in a proprietary digestion process. This product is designed to prevent or correct nitrogen deficiencies and should be used as part of a comprehensive nutrition plan for sustaining plant growth, development, yield, and quality. It can be used on field, specialty, and horticulture crops, including turf, ornamental, and greenhouse plants. The optimum rate of application will vary based on a variety of factors including degree of need or deficiency, growth stage, yield potential, environment, existing soil fertility levels, etc. Consult your crop advisor for recommended rates.

ORGANIC AMMONIUM NITRATE 10-0-0 is compatible with many co-applied nutrient sources as well as plant protection products. Always jar test new combinations for compatibility prior to field mixing.

FOLIAR APPLICATIONS: Apply 0.5 to 2 gallons per acre by air, ground or sprinkler. Dilution of 20 gallons of water to 1 gallon of product is recommended. Maintain agitation to provide uniform distribution within the spray tank. Thorough and even spray coverage is essential for maximum nutrient uptake and crop safety. Do not apply when plants are under excessive heat or moisture stress.

SOIL APPLICATIONS: Apply 0.5 to 40 gallons per acre as broadcast, band, side-dress, or injected through irrigation systems (sprinkler, drip, or center pivot). Maintain agitation to provide uniform distribution within the spray tank. If applied to the surface, incorporation within 3 days is recommended.
