GENERAL INFORMATION

Willowood Organosilicone MSO contains a distinct, high-quality combination of methylated soybean oil and organosilicone surfactant. The oil is a superior penetrant that aids certain pesticides in moving through the waxy cuticle of plants and leaves for greater efficiency. In addition, the organosilicone surfactant increases spreading and wetting of the applied solution so that the active moves to and through the plant quickly.

Use Willowood Organosilicone MSO wherever a label calls for an MSO or MVO and allows or does not exclude the use of an organosilicone.

DIRECTIONS FOR USE

Follow directions on the active label and add when the directions specify the addition of an MSO or MVO. If the directions do not indicate a specific order of addition, Willowood Organosilicone MSO may be added any time after all solid materials have been added and completely dispersed. Preferably, add Willowood Organosilicone MSO last before the final addition of water.

USE RATES

May be applied by Ground, Aerial or CDA spray equipment.

Ground: Use 3 – 5 pints per 100 gallons of spray solution.

Aerial, CDA: Use 3 – 5 fl. oz. in 1 – 5 gallons of spray solution.

Use 3 oz. in 1 – 3 gal. and 5 oz. above 3 gal.

NOTE: Some pesticide labels may recommend higher or lower rates of spray adjuvant. When this occurs follow the pesticide label's recommendation.

STORAGE AND DISPOSAL

STORAGE: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
