GENERAL INFORMATION

OS-100 is a nonionic organo silicone surfactant for use in the post-harvest control of Asian Citrus Psyllid on citrus. Always follow the adjuvant use recommendations as shown on the pesticide label.

DIRECTIONS FOR USE

FOGGING AND PRESSURIZED SPRAY ON CITRUS FRUIT IN BINS, BASKETS, ON TRUCKS OR IN PROCESSING PLANTS:

OS-100 may be used in combination with approved insecticides to control Asian Citrus Psyllid. Use **OS-100** at a rate of 0.5% or 2 quarts per 100 gallons of spray solution to achieve desired fruit wetting.

MIXING INSTRUCTIONS:

- 1. Fill tank to 2/3 to 3/4 full of water. If foaming is anticipated, add an anti-foaming agent before pesticide and **OS-100**.
- 2. Add pesticide as directed by pesticide label.
- 3. Continue agitations.
- 4. Add **OS-100** and continue filling tank while maintaining agitation.

USE PRECAUTIONS

OS-100 may lose wetting activity when mixed in solution below pH 5 or above pH 9.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

STORAGE: Store in original container only and keep tightly sealed. Store in closed storage area.
