FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

GENERAL: PENETRON® is a specialized blend of non-ionic surfactants that is suitable for use as a spray adjuvant with certain herbicides. **PENETRON** provides a more uniform coverage of spray solutions and aids in penetration.

DIRECTIONS FOR USE: FOR USE WITH PRODUCTS REGISTERED FOR: FORESTRY, RIGHTS-OF-WAY AND NON-CROPLAND. DO NOT APPLY THIS PRODUCT ON CROPS GROWN FOR FOOD OR FEED. NOT FOR AQUATIC USE.

The use of **PENETRON** to a tank mix should always follow the review of herbicide(s) label(s) and their procedures, rates and application requirements.

RECOMMENDED USE RATES: PENETRON is recommended for use only with glyphosate and other vegetation management herbicides and tank mixtures for forestry conifer release (woody and herbaceous), forestry site preparation and rights-of-way applications.

For conifer release, use up to 10 fluid ounces of this product per quart of glyphosate applied per acre. *Do not exceed 20 fluid ounces per acre of this product for conifer release.

For herbaceous release treatments in newly planted pines in the Southeastern United States, use up to 6 fluid ounces of this product per acre.

For site preparation, rights-of way, and post-directed sprays in established conifer sites, apply a minimum of 1 percent (4 quarts per 100 gallons of spray solution) by spray volume. Use of concentrations of this product greater than 3 percent by spray volume with handheld applicators or 3 percent by spray volume with broadcast applications is not recommended.

*In the Southeastern United States, up to 20 fluid ounces per acre of this product may be used with any recommended rate of glyphosate.

MIXING INSTRUCTIONS: Fill the spray tank (2/3) full with clean water. Add the recommended rate of glyphosate followed by the recommended amount of this product. Fill spray tank to desired level. Ensure that the spray solution is thoroughly mixed. If needed, use an approved antifoam or defoaming agent.

STORAGE AND DISPOSAL

STORAGE: Suggested storage above 40°F. If frozen, warm product before use. Store in cool, dry place. Store in original container. Keep tightly closed. Do not reuse empty container.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Wastes may be disposed of on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
