

GENERAL: PhosPro o-20-20 is a reacted phosphate product, which provides supplemental plant available phosphate. Increasing phosphate levels inside the plant tissue has shown beneficial in promoting cell elongation and wip growth.

**DIRECTIONS FOR USE:** PhosPro 0-20-20 may be applied foliar or to the ground using boom, air blast or injected through irrigation systems. Always conduct a jar test to check compatibility with other products. This proprietary formulation is for use on fruit trees, and berries. Exact rate recommendations should be made based on tissue and soil analysis. Plant injury can occur if the product is misused. Refer to a certified crop consultant for additional information.

**SOIL APPLICATIONS:** Apply 24L /Ha in a minimum 40oL water per Ha. (3 Ga/Acr in a minimum of 44 Ga water per acre.) **FOLIAR APPLICATIONS:** Apply 50omL - 2.4L /Ha in a minimum of 100oL water/Ha. (7-33.75 fl oz/Acr in a minimum of 110 Ga water per Acr.) Repeat applications as needed. Do not apply more than 3 applications per season. PhosPro 0-20-20 must be well mixed with water before application. Conduct a jar test for tank mixing with other products.

FIRST AID: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse.
