follow the pesticide directions. Consult your Fieldman for advice to best fit your needs.

## RATES

1. For applications using 5 to 20 gallons of water per acre, use 2 quarts per acre.
2. For applications using no water to 2 gallons of water per acre, use 1 quart per acre.
3. For citrus sprays that use 100 to 500 gallons of water per acre, use 1% of the volume of the water.
4. For dormant orchard sprays that use 100 to 500 gallons of water per acre, use 1% to 2% of the total volume of the water.
5. For concentrated controlled droplet application (CDA) when no water is added, use 3 to 5 pints per acre. For controlled droplet applications with water, use 15% of the total liquid volume. Do not exceed 2 quarts per acre.

## STORAGE AND DISPOSAL:

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Store in original container only. Store in cool, dry place and avoid excess heat. Carefully open containers. After partial use, replace lids and close tightly.

**Disposal:** Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
