GENERAL INFORMATION

PHT PIERCE is a unique blend of highly refined and modified spray oil and superior nonionic surfactants. PHT PIERCE's unique chemistry allows for superior wetting and absorption of those pesticides or products which labels recommend the addition of a spray adjuvant to improve coverage. The addition of PHT PIERCE to a spray tank solution will improve a spray application by physically modifying the deposition and wetting characteristics of the spray solution, the result being a more uniform spray deposit. This product cannot be used for aquatic applications.

The use of PHT PIERCE can increase pesticidal activity where the following factors occur, but is not limited to:

1. When used in areas of the country with low relative humidity and high temperatures.
2. When target species are larger than label recommendations at time of application.

DIRECTIONS FOR USE

NOT FOR AQUATIC USE. Application rates will vary depending on the application method, equipment, size of the spray droplet, water hardness and other conditions of the application. Higher rates than recommended on this label may be used if recommended on the pesticide label. Follow the pesticide label directions. **DO NOT ADD PHT PIERCE AT A RATE EXCEEDING 5% OF THE FINISHED SPRAY VOLUME, EXCEPT WHEN USED AS A DILUENT IN DORMANT, BASAL, SITE PREPARATION OR OTHER SIMILAR APPLICATIONS, PER LABEL INSTRUCTIONS.**

Herbicides, Defoliants, Desiccants (Air or ground): Apply 1 1/2 - 2 pints per acre. Use caution when applying with selective herbicides. Higher rates may be required on hard-to-control weeds or weeds which are under stress.

Fungicides, Insecticides, Miticides: Apply 1/2 to 1 pint per 100 gallons of spray mixture. For best results use a minimum of 1/2 - 1 pint per acre when finished spray volume is less than 20 gallons per acre. For backpack or hand held sprayers, use 1/2 - 1 fluid ounce per gallon of finished spray solution.

NOTE: The application rates on this label are based on pesticide labels which recommend the use of a methylated seed oil or nonionic surfactant. Use the rate recommended on the pesticide label. A compatibility test is recommended prior to use.

MIXING

Prior to pesticide application, clean mixing and application equipment according to pesticide label directions.

To minimize foaming fill spray tank 2/3 or 3/4 full of water. If foaming is anticipated, the addition of an antifoaming agent should be added before pesticides, nutrients, or PHT PIERCE. Add pesticides and/or fertilizers as directed by label or in the following sequence: A. Micronutrients and fertilizers, B. Dry flowables and dispersible granules, C. Flowables, D. Water soluble pesticides, E. Emulsifiable concentrates. Continue agitation and add PHT PIERCE. After the addition of PHT PIERCE, reduce agitation and allow to mix for 1 to 2 minutes. Continue filling tank while under minimal agitation.

NOTE: For optimum results, spray mixes containing PHT PIERCE should be applied within 36 hours.
