PondMaster® Watercolors™ Shimmer Blue is a proprietary blend of environmentally friendly colorants that impart a shimmering blue to aquamarine color to lakes and ponds while reducing sunlight penetration and maximizing surface reflectivity. The dye packet is protected by a waterproof outer wrapper to prevent accidental staining while handling. The packet and dye will dissolve quickly in water and treated water is non-toxic to horses, cattle, aquatic plants, turfgrass, waterfowl, mammals, reptiles, fish or other aquatic species.

Irrigation, swimming and other recreational activities are approved following the use of this product. Applications to chlorinated water may require more frequent treatment.

GETTING STARTED

WHERE TO USE:

For application to ponds, lakes, fisheries and ornamental bodies of water.

IMPORTANT: Do not apply this product to water intended for direct human consumption. Do not use this product for streams, rivers or other bodies of water which are not under the control of the user. Only use this product in accordance with local, state and federal regulations.

HOW MUCH TO USE:

Each packet will effectively treat 1 acre of water 1 foot deep.

Most lakes and ponds should be treated to a depth of 4 feet. To determine the initial number of packets to apply to a depth of 4 feet, multiply the surface acres of the body of water to be treated by 4. If you do not know the surface acres of the water to be treated, measure the length and width of the pond and use the formula below:

$$\frac{\text{Length in feet} \times \text{Width in feet}}{43,560} \times 4 = \text{Number of packets to use}$$

HOW TO USE:

Open the end of the waterproof outer wrapper by using the convenient tear strip located at the top of the package. Holding the outer wrapper, drop or throw the dissolvable inner packet into the body of water to be treated. If necessary, apply packets at multiple locations as needed. Water temperature and degree of agitation will influence how quickly the dye packet dissolves.

Once the initial colorant treatment has completely dispersed, you may add additional packet(s) to increase the color intensity if desired.
