GENERAL INFORMATION

POSTURE™ is a water soluble, foliar nitrogen product. It can be mixed with most commercially available fungicides, insecticides and nutrient products.

DIRECTIONS FOR USE

POSTURE is designed for application to plants as a foliar spray, root dip or as a soil drench. It can be applied by air or by ground.

Compatibility can be checked by:

- Mixing each product in a clear container in the same proportion to be used in the spray tank.
- Agitating vigorously for at least 30 seconds.
- Visually observing for precipitate formation.

NOTE: POSTURE should be used within 2 days of mixing.

APPLICATION

ALMONDS: Apply 5 pounds per acre during the period of pink bud through jacket split. This product is pH neutral and can be applied with other nutrients and plant protection products. POSTURE is not compatible with products containing phosphate or phosphite.
