Tank Mixing

Followed the instructions on the pest control product manufacturers label. If there are no specific instructions, add PREFER 90 after the pest control product has been thoroughly mixed into the tank mix water and preferably after all products have been mixed into the tank.

First Aid

If in eyes: Hold eye open in rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor immediately for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor immediately for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have the person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by poison control center or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then if possible, give artificial respiration, preferably by mouth-to-mouth. Call a poison control center or doctor immediately for treatment advice.
