GENERAL INFORMATION

Premium Plant Tea is a "Plant Extract Tea". Rather than using compost or animal wastes, BioGro has taken live plants and specific plant parts and "steeped" them in various media solutions. The resulting solutions are allowed to ferment under controlled conditions and stabilize.

Premium Products actually have a long shelf life and can be stored under proper conditions for 1-2 years. Premium Products do not smell "rotten" and should not be used if they do.

DIRECTIONS FOR USE

It is recommended to shake, stir or agitate containers or tanks of Premium Plant Tea just prior to usage.

Mixing Directions - Be sure spray tank is thoroughly cleaned, fill 1/3 full with clean water, add product and continue filling with agitation.

Compatibility - Premium Products are compatible with most fertilizers and bioproducts. Consult your BioGro dealer for more information.

Use this product (preferably blended with liquid nutrients) during periods of rapid root development.

SUGGESTED APPLICATIONS

Optimum rate of application will vary between fields depending on soil and/or climatic conditions, stage of crop growth and size of plants. The best timing is at planting or when a root flush is occurring. Consult your BioGro dealer for specific recommendations.

All Fields, Vegetable Crops, Trees and Vines - Apply 5-30 gallons per acre at planting. Water run 5-30 gallons per acre during germination. Water run 5-30 gallons per acre with applied fertilizers during growing season. - Apply 2-5 gallons per acre in spring and fall during root flush.
