#### FOR FOLIAR / SOIL APPLICATION

**Pro-Bean™ Mix** is recommended as a foliar or soil applied fertilizer for use on any food or fiber crop where the addition of one or more of the nutrients contained in **Pro-Bean Mix** would be beneficial. A number of variables influence the rate of application necessary to control or correct a specific deficiency. For best results, follow good agronomic practices, soil test and, if necessary, use tissue analysis.

**Foliar Application:** Apply 1 to 2 quarts/acre prior to or immediately after deficiency symptoms occur to prevent or alleviate losses from nutrient deficiencies. Spray carrier (water) volumes of 10 to 20 gallons per acre (ground) or 5 gallons per acre (air) are recommended for best results. When deficiency symptoms are severe, a repeat application of 1-2 quarts/acre may be needed 2 or more weeks following the initial application.

**Soil Application:** Apply 1 to 2 quarts/acre as a starter fertilizer in a balanced fertility program.

#### DIRECTIONS FOR USE

Mixing Instructions when tankmixing with glyphosate

1. Start with a clean spray tank.
2. Fill the spray tank 1/3 - 1/2 full of water.
3. While continuing to fill with water add water conditioning product and/or Ammonium Sulfate at recommended rates
4. Add **Pro-Bean Mix**
5. Add glyphosate herbicide
6. Fill remainder of tank and agitate

**Note:** All micronutrient additives have the potential to cause antagonism of glyphosate herbicides. A quality water conditioner and/or ammonium Sulfate is recommended to help to alleviate antagonism potential.

**WARNING:** This product contains boron (B) and may be harmful to certain crops. Use only according to manufacturer's directions.

#### FIRST AID

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. **If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. **STORAGE:** Store product in dark fiberglass or plastic containers out of direct sunlight or UV light. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. **PROTECT FROM FREEZING.** Do not contaminate water, food, or feed by storage or disposal. **DISPOSAL:** Do not reuse container. Triple rinse (or equivalent) and add rinsate to spray tank, then offer for recycling at an ACRC site (go to <http://www.acrecycle.org/> for locations) or by reconditioning, or puncture and dispose of in a sanitary landfill or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke. Do not contaminate water sources by runoff from cleaning of equipment, disposal of equipment wash waters or spray waste. **HANDLING:** Avoid breathing fertilizer mists. Avoid prolonged or repeated skin contact. Avoid eye contact. Wash hands thoroughly after handling this product.
