**DIRECTIONS FOR USE:** This product is to be used where Boron deficiencies have been identified by soil/tissue analysis. Seek the advice of a certified crop consultant for application rates and timings for desired crops. For use in berry crops, tree fruits, field vegetables and grapes during flowering stages.

SOIL APPLICATIONS: Apply 9-14L(2.38-3.70Ga) / Ha. Do not exceed 2oL(26.4Ga) per growing season FOLIAR APPLICATIONS: Apply 1-2L(0.26-0.53Ga) in 6ooL(158.5Ga) water / Ha. Repeat applications as needed. Do not exceed 5L(1.32Ga)/Hectare per year.

Pro Boron 10% should be well mixed with water before application. Conduct a jar test for tank mixing with other products.

FIRST AID: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse.
