Seek the advice of a certified crop consultant for application rates and timings for desired crops. For use in berry crops, tree fruits, and grapes:

SOIL APPLICATIONS: Apply 500ml - 4L per hectare (7-28 fl oz/Acre). Do not exceed 6L/Ha (85 fl oz /Acre )per season FOLIAR APPLICATIONS: Apply 500ml - 2L in a minimum of 450L water / Ha (7-67 fl oz in a minimum of 50Ga water per acre). Repeat applications as needed

Pro Mag should be well mixed with water before application. Conduct a jar test for tank mixing with other products.

**FIRST AID:** If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse.
