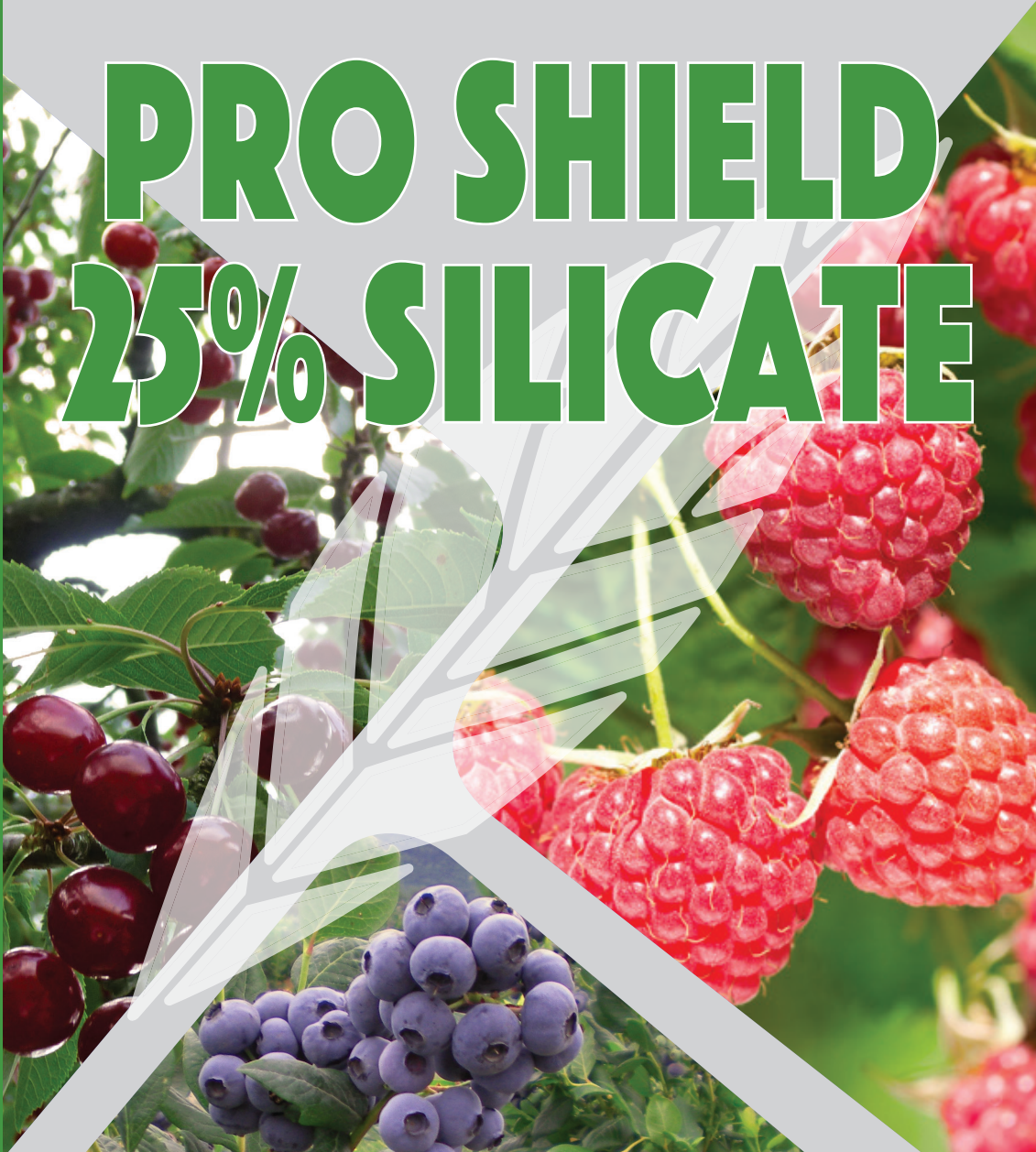

GENERAL: Pro Shield 25% silicate is a pure reacted silicon dioxide, which provides a supplemental plant available silica which serves to physically strengthen and protect the plant from stress.

DIRECTIONS FOR USE: Pro Shield 25% silicate may be applied foliar or to the ground using boom, air blast or injected through irrigation systems. Always conduct a jar test to check compatibility with other products. This proprietary formulation is for use on horticulture crops, vegetables, fruit trees, and berries.

SOIL APPLICATIONS: Apply 200-800mL (6.76-27.05fl oz) /Ha in a minimum 400L(105.67Gal) water/Ha.

FOLIAR APPLICATIONS: Apply 200-800mL (6.76-27.05fl oz) /Ha in a minimum 550L(145.29Gal) water/Ha.

Repeat applications as needed. Do not apply more than 4 applications per season. Pro Shield 25% silicate must be well mixed with water before application. Conduct a jar test for tank mixing with other products.

FIRST AID: If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse. If in eyes: Flush with running water for at least 15 minutes while holding eyelids open. Get medical attention. Ingestion: Drink 1-2 glasses of water and induce vomiting. Never induce vomiting or give anything by mouth to an unconscious person. Call physician immediately. Inhalation: Remove to fresh air. If breathing is difficult, administer oxygen.
