### DIRECTIONS FOR USE

Use 150 - 200 pounds of ProNatural<sup>®</sup> Dry 6-2-1 per orchard acre banded (375 - 400 pounds per treated acre) post-harvest or early spring. Do not exceed 400 pounds per orchard acre banded (1,000 pounds per treated acre). ProNatural Dry 6-2-1 can be top-dressed under sprinklers or lightly incorporated. Not recommended for use under drip irrigation if drip is the sole source of water.

### FIRST AID

In all cases, call a poison control center or doctor for further treatment advice.
