ProNatural® PHOTO MAX PLUS is manufactured and designed for foliar applications on plants to prevent or correct trace element deficiencies that usually occur when plants are small and may limit crop growth and yields. **ProNatural PHOTO MAX PLUS** is readily available and rapidly absorbed by the plant because of the natural complexing properties. It is water soluble and non-toxic to plants when applied as directed.

ProNatural PHOTO MAX PLUS is a yield-enhancing formulation that contains amino acid complexed micronutrients. **ProNatural PHOTO MAX PLUS** enhances plant growth and development by stimulating nutrient uptake, nutrient penetration and nutrient utilization.

ProNatural PHOTO MAX PLUS is a proprietary formulation that provides a wide range of mixing ease with other fertilizers or chemicals.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USING. KEEP FROM FREEZING.

Dilute one part **ProNatural PHOTO MAX PLUS** with 20 or more parts water. Apply using a spray method and in an adequate amount of water that will provide complete coverage of the plants. Use of a nonionic wetting agent may improve spray coverage of certain hard-to-wet plants. **Do Not Apply Undiluted.**

ProNatural PHOTO MAX PLUS can be included in a regular spray program on crops. Consult with a Wilbur-Ellis representative on compatibility with other spray materials. The rate of application will depend on the crop, stage of growth, and severity of deficiency. The maximum recommended rates are for mature, full-sized plants. Reduce the rates proportionately when spraying smaller plants.

ProNatural PHOTO MAX PLUS may be used on legumes, grain crops, root crops, cucurbits, cole crops, leafy vegetables, woody and herbaceous ornamentals, deciduous fruit, vine crops, tropical and subtropical fruit, and many other crops.

Apply 1-3 quarts per acre as needed on young growing crops including tree fruit, wine grapes and blueberries.

APPLES: Apply 2 quarts per acre pre-bloom, 4 pints per acre post-bloom, and another 4 pints per acre every 7-10 days as needed.

PEARS: Apply 1.5 quarts per acre pre-bloom, 3 pints per acre post-bloom, and another 3 pints per acre every 10 days for an additional 4 applications.

CHERRIES: Apply 2 quarts per acre as needed.

CAUTION: Not fully chelated. Avoid mixing **ProNatural PHOTO MAX PLUS** with product containing calcium chloride.
