**PURIC™ MAX SB** is formulated for maximum dispersion and compatibility in blends with limited agitation. **PURIC MAX SB** may be applied to a wide range of agronomic and ornamental plants to prevent or correct nitrogen deficiencies and may enhance nutrient uptake. Avoid using this product with acids and oxidizers. This product is a weak alkaline solution and may alter the pH of certain solutions. A weak acid may be used to reduce the pH of the spray solution. This product may be applied with various irrigation systems.

### DIRECTIONS FOR USE

**FOLIAR:** Apply 1-2 quarts or more per acre with sufficient water for thorough coverage. Apply this product by air or ground application. This product is a weak alkaline salt and may be neutralized with a buffer. When in doubt, test this product on a small scale.

**SOIL:** Apply 1 quart to 5 gallons or more per acre with fertilizer or with water. Higher rates or repeated applications may be beneficial.
