GENERAL INFORMATION

PURIC® PRIME 1-0-2 humic acids solution may be applied to most crops and may enhance micronutrient uptake. This product is readily dispersed in most fertilizer or micronutrient products. It is a weak alkaline solution and may alter the pH of certain solutions.

DIRECTIONS FOR USE

FOLIAR: Use 1-3 quarts per acre with sufficient water for thorough coverage by air or ground application. This product is a weak alkaline salt and may be neutralized with a buffer.

SOIL: Apply 1 quart to 5 gallons or more per acre with fertilizer or with water. Higher rates or repeated applications at lower rates may be beneficial. If applying alone, it is recommended to mix 1:1 with water.

FERTIGATION: PURIC PRIME 1-0-2 may be water-run in open systems or injected into closed irrigation systems at rates of 1-5 or more gallons per acre. May be applied with other liquid fertilizers.

COMPATIBILITY: PURIC PRIME 1-0-2 is formulated for improved compatibility with liquid fertilizer solutions. Many fertilizers will mix spontaneously with this product. For some fertilizers, dilution with one volume of water per volume of PURIC PRIME 1-0-2 may be needed for ease of mixing. This product may require agitation when mixed with a concentrated phosphate fertilizer such as 10-34-0. Do not mix with acid fertilizers or with solutions having a pH less than 5.0. Proposed mixtures should be evaluated in a jar test before full scale use. To reduce risk of incompatibility, follow this sequence of mixing:

1. Water
2. PURIC PRIME 1-0-2
3. Fertilizer
