**PURIC® SALUTE®** humic acid solution may increase micronutrient uptake and can be applied to most crops. This product readily disperses in fertilizer or micronutrient solutions, including acid-based fertilizers and calcium fertilizers.

This product may alter the pH of certain solutions. This product may be applied with various irrigation water systems.

### DIRECTIONS FOR USE

**FOLIAR:** Apply 1-8 pints per acre with sufficient water for thorough coverage by ground or air application. This product is a weak acid salt and may be acidified further.

**SOIL:** Apply 1 quart to 5 gallons or more per acre with fertilizer or with water. Higher rates or repeated applications may be beneficial. This product may require agitation when mixed with fertilizer for prolonged periods.

**FERTIGATION:** **PURIC SALUTE** may be water-run in open systems or injected into closed irrigation systems at rates of 1-5 or more gallons per acre. May be applied by itself or with liquid fertilizer. For specialized uses, please contact your local Wilbur-Ellis representative.
