GENERAL INFORMATION

PURIC® ZINC PRIME is designed for application to the soil. **PURIC ZINC PRIME** is highly effective under adverse soil conditions unlike other zinc compounds that are tied-up and unavailable to the plant. These adverse conditions include: high phosphate soil levels, high pH (alkaline), high salinity, high carbonate levels, and clay soils (adsorption). EDTA products may be applied separately or in combination with fertilizers or pesticides. **PURIC ZINC PRIME** is recommended for soil application only.

DIRECTIONS FOR USE

SOIL APPLICATIONS FOR TREE FRUIT AND NUT CROPS: Apply 1-10 gallons per acre with pesticides, fertilizers, or irrigation water (emitters, drip or overhead). Correction may not be evident for several weeks. **PURIC ZINC PRIME** is not intended to be applied to foliage as severe damage to plant may result.

APPLICATIONS FOR ROW, FIELD AND VEGETABLE CROPS: Applications of **PURIC ZINC PRIME** are preferred at planting or shortly before emergence. Applications prior to bloom or pollination should be injected or applied to the soil. Split applications are preferred over a single application.

SOIL: Apply with pesticides, fertilizers or irrigation water (drip or emitter) at 1-8 gallons per acre. **PURIC ZINC PRIME** may be applied preplant (as near as possible to planting), during planting (close to seed) or postemergence as a layby or shanked application.

COMPATIBILITY

Always jar test new combinations for compatibility prior to field mixing.
