QHP™ + can be applied to all fruiting crops including: vegetable crops, row crops, field crops, trees, vines, ornamentals, gardens, and landscaping. **QHP™** + is specially formulated for flowering plants and crops. It is therefore recommended for use on crops that pass through a flowering stage and that are harvested for their fruiting structures. Use **Hydra-Hume®** on other non-flowering crops.

QHP™ + can be applied to all soil types and pH ranges and through irrigation waters, and with various fertilizers.

QHP™ + can be mixed with most liquid nitrogen and phosphate fertilizers, including side dress, and water runs. It is not advised, however, to mix **QHP™** + with Calcium (Ca) containing fertilizers.

QHP™ + is compatible with many fertilizers, nutrients, pesticides and fungicides. If unfamiliar with its use, be sure to check with Helena Chemical Company for compatibility, or perform a jar test, mixing each product in the same ratio as to be field applied.

Fertilizers or nutrients with an extremely low pH are compatible with **QHP™** +. It may be necessary to agitate your mix to obtain an even distribution of all components.

QHP™ + is not a replacement for **Hydra-Hume®** liquid, but is designed to supplement its usage on flowering plants during the pre-bloom and early bloom stage.

DIRECTIONS FOR USE

WATER-RUN APPLIED: The preferred application method is to apply 1 gallon per acre at the first appearance of flower buds, then apply a second 1-gpa application 2 weeks later. A third application of 1-gpa can be applied every 2 weeks on vineyards, orchards, tomatoes, cotton, watermelons, cantaloupes, peppers, and strawberries.

A single water-run application of 2 to 3-gpa timed to coincide with the first appearance of flowering buds has shown to be very effective in tomatoes and cotton.

SIDE-DRESS APPLIED: **QHP™** + can be sidedressed by knifing a band of **QHP™** + into the soil at 2 to 3 gallons per acre. The ideal timing for sidedress is just before 1st bloom.

PIGGYBACKED WITH NUTRIENTS: **QHP™** + can be mixed with nitrogen fertilizers like **UAN-32** and applied either as a water-run or as a side-dress. The timing for **QHP™** + applications when piggybacked with nutrients should be the same as described above.

Turf: Apply 2 quarts to 1 gallon per acre (1.5 oz to 3.0 oz/1,000 sq. ft. and incorporate into the roots zone by irrigation.

DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN.
