#### **DIRECTIONS FOR USE:**

#### TIME OF DAY TO SPRAY

RAIN CHECK should be sprayed at a time of the day/night which allows complete drying prior to any rain in order to achieve maximum result.

#### GENERAL APPLICATION RATES APPLICATION FREQUENCY

RAIN CHECK should be sprayed as required. Contact your local Loveland Products or Crop Production Services support representative for further advice.

#### **APPLICATION RATES**

Cut Flowers, Tomatoes, Onions, General Row Crops, Bell Peppers, Grapes and Vines, Chiles, Vegetables, Potted & Exotic Plants and Melons : 2 to 3 quarts per acre.

Citrus, Fruits, Pears, Avocados, Plums, Bananas, Apricots, Mangos, Peaches, Nut Trees, Cherries, Apples, and all larger sized trees: 3 quarts to 1 gallon per acre.

#### FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.
