## GENERAL INFORMATION

REGUARD® O is a proprietary blend of pinene polymers and emulsifiers designed for use as an extender and sticker to increase the longevity of pesticides. It may be used with all pesticide products and soluble fertilizers. REGUARD O forms a durable film that adheres a pesticide or soluble fertilizer to the crop foliage and can lead to enhanced activity of the crop input. This shield decreases the effects of environmental factors that may erode the effectiveness of pesticides and soluble fertilizers. REGUARD O resists the removal of the pesticide or soluble fertilizer from the leaf surface by rainfall, sprinkler irrigation and wind.

REGUARD O will not foam or clog nozzles. It may be applied by air or ground, including application through a concentrate sprayer.

REGUARD O sprays require sufficient drying time for best adhesion, under most conditions. Allow at least one hour of daylight after REGUARD O spray application and prior to an anticipated rain. Sunlight during this time period is required for the protective shield to set.

## NOT FOR AQUATIC USE

### COMPATIBILITY

REGUARD O is compatible with most agricultural chemicals. However, a jar test is recommended before mixing it with other chemicals in large quantities.

### MIXING DIRECTIONS

Fill the spray tank half full of water, then add other desired components to the tank while agitating the mixture. Premix REGUARD O with more water and add while the tank continues to fill. Agitate mixture continuously while the tank is filling.

Use clean water to rinse spray equipment immediately after spraying. Though some residue may remain in the tank, it will help prevent rusting and corrosion and will not clog nozzles next time the sprayer is used.

### USE PRECAUTIONS

Do not apply this product to non-target surfaces and do not allow spray to drift. Permanent damage may occur on porous surfaces. On non-porous surfaces, remove spray immediately with soap and water while the spray deposit is still wet. Dried deposits on painted car surfaces can be removed using standard tar remover products designed for use on cars.

Do not apply when the weather is hot, windy or wet. Apply only when you are certain that the application will give you the desired result.

Do not allow spray drift or rinse water from spray tank to contaminate surface waters.

### DIRECTIONS FOR USE

To improve the activity and efficiency of pesticide sprays and soluble fertilizers apply 4 to 16 fluid ounces of REGUARD O per acre.

To improve the absorption and retention of foliar fertilizers, apply 4 fluid ounces of REGUARD O per acre.

For use in air blast sprayers or hydraulic gun sprayers:

Concentrate sprays (100 gallons or less spray volume): Apply 4 to 16 fluid ounces of REGUARD O per 100 gallons of water.

Dilute Sprays: Apply 4 to 8 fluid ounces of REGUARD O per 100 gallons of water.

Do not apply REGUARD O to food crops within 30 days of harvest except as follows: REGUARD O can be used with copper fungicides, *Bacillus thuringiensis* products and other tolerance exempt pesticides on food crops up to harvest.

**Note:** Use of REGUARD O with tolerance exempt pesticides close to harvest may result in visible residues on crops which may render the crops unsalable. If this is a potential problem, REGUARD O rate should be reduced or should not be used close to harvest. Do not apply to food crops within 30 days of harvest when *Bacillus thuringiensis* products are combined in the spray tank with other insecticides.
