REVERT has not burned turf when applied according to label directions.

**DIRECTIONS FOR USE:** Greens, Tees, Fairways, Lawns, Parks and Sports Turf  
**Localized Dry Spot and Water Repellency Conditions:** Apply REVERT at 6 oz. per 1000 sq. ft. on a 30-day program. REVERT should be applied in a 2 gallon spray solution per 1000 sq. ft.

## STORAGE AND DISPOSAL

**STORAGE:** Store in a cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container.

**DISPOSAL:** Do not contaminate water, food or feed by storage or disposal. Dispose of contents/container on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities.
