## FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, or going for treatment.

*REVISTA* is a nonionic organosilicone wetting agent designed for use with: crop protection products, plant growth regulators, fertilizers, microbial products, and plant nutritional. *REVISTA* lowers spray solution surface tension to improve wetting and uniformity in leaf surface coverage beyond that of ordinary surfactants.

*REVISTA* is ideal for use where coverage is critical. It is especially well suited for low water volume applications made by ground or aerial equipment where spray coverage may be a limiting factor.

NOT FOR AQUATIC USE

## DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and / or fertilizers and their tank mixes may cause phytotoxicity to the foliage and / or fruit of desirable crops. Before using *REVISTA*, the applicator or crops advisor must have experience with the pesticide combination, including *REVISTA*, or must have conducted a phytotoxicity test.

**Do not use *REVISTA*** in applications containing boron, as unacceptable crop injury may occur.

**Do not use *REVISTA*** in applications where the spray solution is below pH 4.0 or above pH 9.0.

Reduce spray volumes to avoid excessive run-off of the spray solution and poor performance.

Apply within 24 hours of mixing for best results.

## APPLICATION RATE RECOMMENDATIONS

**Ground:** Use 3.2–13 ounces per 100 gallons of spray solution.

**Aerial:** Use 12–19 ounces per 100 gallons of spray solution.

**Irrigation:** *REVISTA* can be applied at rates of 4–12 oz per 100 gallons through irrigation systems utilizing drip tubes, tape or micro emitter heads.

## MIXING INSTRUCTIONS

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inducer, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed.
2. AMS, dry formulations (WP, DF, WG, SP), and dry drift retardants.
3. Dry soluble and suspension fertilizers / micronutrients.
4. Liquid drift retardants and flowable formulations (F & FL).
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME).
6. Emulsifiable concentrates (E, EL or EC).
7. Solutions and soluble liquids (S or SL).
8. Liquid micronutrients and fertilizers.
9. Water conditioners (*REVISTA*) and other adjuvants (COC, HSOC, MSO, NIS).
10. Finish filling to desired spray volume level and continue agitation.
