#### GENERAL RECOMMENDATIONS

Before including any other fertilizer with RiseR<sup>®</sup> in seed furrow applications conduct a jar test of the products to be mixed in their respective proportions and observe it for 24 hours, before mixing large quantities. The person making the recommendation or application is responsible for verifying the seed safety of any products mixed with RiseR. When used as directed this product does not supply all nutrients required by plants and is to supplement a soil fertility program based on soil tests.

**SOIL or FOLIAR APPLICATIONS:** Use 2 to 5 gallons RiseR per acre in furrow at planting or foliar application. Water may be added to dilute RiseR when higher volume application is desired. Optimum rate of application will vary between fields, depending on soil pH and organic matter content. For best results, follow soil test or plant analysis recommendations.

**TRANSPLANT SOLUTIONS:** Use 0.5 to 1.5 gallons of RiseR per acre in 100 gallons/acre transplant water. For tobacco transplant solution use 0.5 to 1.5 gallons of RiseR per acre in 100 gallons/acre.

**CROPS:** Almonds, Artichokes, Avocados, Blackberries, Blueberries, Broccoli, Brussels sprouts, Cabbage, Cane berries, Cantaloupes, Cauliflower, Celery, Cereal grains, Citrus, Corn, Cotton, Grass for Seed and Turf, Hazelnuts, Lettuce (head and leaf), Melon, Peppers, Pistachios, Romaine lettuce, Squash, Strawberries, Table and Wine Grapes, Tobacco, Tomatoes, Walnuts, Watermelon.

#### HANDLING INSTRUCTIONS

Store and transport RiseR in Poly or stainless steel only. Thoroughly agitate RiseR before transferring to another vessel. Jar test RiseR for compatibility before mixing in any other fertilizer, pesticide, or water which is acidic or basic.

#### FIRST AID

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Store at ambient temperatures. Do not contaminate water, food, or feed by storage or disposal. **DISPOSAL:** Triple rinse (or equivalent), adding rinse water to spray tank, then offer for recycling at an ACR site (go to <http://www.acrecycle.org/> locations for) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.
